The City has asked PCPOA to provide input on the Dockweiler intersection alternatives. In turn, we want to hear from our property owners. **Please review the information in this flyer and plan to attend the Quarterly Meeting on Thursday, March 5, 2020 at 7 p.m. on the North Campus of The Master's University.** If you are unable to attend but wish to express your opinion, please email placeritacanyonpoa@gmail.com no later than Wednesday, March 11, 2020.

The City has provided two alternatives with a roundabout and one with signalized lights. We know many owners voiced opposition to a roundabout when first discussed, however, we have learned that it provides a calming measure that would lower speeds at a critical intersection and has higher safety rates than signal lights. The Board proposed several hybrid alternatives, which we have asked to be considered. PCPOA will continue to work on an alternative that (1) provides the highest level of safety and security, (2) facilitates ingress and egress for Canyon goers, and (3) minimizes Dockweiler downhill speeds when nearing the connecting intersections.






### **Dockweiler Drive Rendering**
